Motion passed by unanimous vote.

County Sheriff Derek Olson met before the Board to discuss submitting a candidate for the CEE IV Task Force. He explained the multi-county arrangement and the services provided by the task force.

County Engineer Jeremy Gilb updated the Board on the State's Local Road Improvement Project grant program available to small cities and townships. The Board and Mr. Gilb discussed the County's assistance to local jurisdictions should they chose to apply.

Motion by Commissioner Lieser, second by Commissioner Jaenisch to enter a closed session to discuss labor negotiation strategy. Motion passed by unanimous vote.

Motion by Commissioner Lieser, second by Commissioner Pauling to open the public meeting.

There being no further business to come before the Board, the meeting was adjourned.
